

## Letter from the Board Chair & Executive Director

#### Dear Friend,

Often described as "a year like no other," 2020 was a historic time of trial for the United States and the broader world. The global COVID-19 pandemic rendered this a year of physical separation, loss, and mourning for far too many. The public health crisis shed light on entrenched inequity and injustice in this country, taking an outsize toll on communities of color. In many ways, it was a year of grief and lament.

At Justice Revival, it was also a year for expanding and deepening our commitment to a mission that proves more vital and urgent than ever: inspiring and mobilizing U.S. Christian commitment to the full range of human rights for all people.

We seized opportunities to speak truth plainly and faithfully about the threats and violations that this virus laid bare. With Faith in Healthcare, we hosted online events reaching over 60 health care professionals and faith leaders, highlighted the inequities of our health system, and made the Christian case for universal health care as a moral imperative. We convened a public roundtable with renowned human rights leaders with The Forum on Human Rights at the Carter Center, illustrating how faith leaders and communities can draw from the power of global human rights to advocate for police reform in the wake of the merciless killing of George Floyd and the systemic threat to Black lives that infects our criminal system and culture. As members of the U.S. Human Rights Network, we successfully called for an extraordinary session of the UN Human Rights Council to address racist state violence.

Justice Revival stepped forward as a central leader of the interfaith movement for constitutional equality, bringing fellow faith and justice champions into the ERA Coalition as advocates of the Equal Rights Amendment. While mourning the loss and celebrating the legacy of the late Justice Ruth Bader Ginsburg, we called American Christians to reject subordination based on gender as well as race, and to insist that all persons be included as full equals under our nation's founding charter.

Although various in-person church engagements and advocacy conferences were necessarily postponed due to the pandemic, we felt fortunate to be able continue each of our ministry initiatives remotely, with some adjustments. We updated the strategy for our signature Christian Human Rights Education program, laying plans to provide dynamic, online, multi-media resources that churches can use independently. Our 2021 virtual event series, "The Heart of Human Rights: Faith-Fueled Advocacy on Issues of Our Day," is the first result.

As difficult as 2020 proved to be, it was also a year when more Americans became conscious of the weight of injustice in our country and open to the Spirit's prompting to be agents of much-needed change. We take heart, yet again, that we serve a God who loves justice fervently and is constantly working to redeem the world—in and through the flawed human people, like ourselves, whom God is also busy redeeming.

We'd like to thank you, the Justice Revival community, for encouraging and supporting the work of this ministry in a host of ways.

Whether you joined us for an online program, spoke out for human rights when called upon, or shared your time and talents in other ways, know that your efforts are making the difference. We remain deeply grateful to each of you who generously provides financial support to help make Justice Revival's work possible.

# Christian Human Rights Education Program

## The Transition to Remote Learning

Central to Justice Revival's work of engaging U.S. Christian communities to advance human rights at home is our flagship Christian Human Rights Education (CHRE) program.

During 2020 Justice Revival was able to provide four Sunday mornings of in-person adult education before the social distancing mandate of the pandemic prevented us from gathering for the remainder of the year and postponing some events into 2021.

Our friend **Steve Fox**, Co-Chair of the Adult Education Lay Ministry at **Bradley Hills Presbyterian Church**, called the sessions "superb, drawing from historical, sociological, and theological sources from a wide variety of cultures," and added that he highly recommends Justice Revival's teaching for "serious lay audiences interested in addressing justice and human rights issues."

As the nation adjusted our ways of living, learning, and working in response to the crisis, Justice Revival worked to provide timely and topical human rights insight.

In May we hosted **Professor Fran Quigley** of **Faith in Healthcare**for a webinar focused on the

human right to health in the time of COVID-19. With **Justice Revival Board Member Derick Dailey** as moderator and **Allyson McKinney Timm** as co-presenter, the event explored what Christianity and other traditions have to teach us about the moral imperative of healthcare, and what human rights requires of a wealthy nation like the U.S.

Justice Revival expanded our partnership with **The Forum on Human Rights at the Carter Center**, providing online education programs in 2020 that reached hundreds of viewers. Justice Revival designed and hosted roundtable events on racial and gender equity, in which Allyson McKinney Timm moderated timely panel discussions featuring leading faith and justice experts.

In March we presented "Religion, Gender, Justice, & Equality: Faith Leaders Reflect on the Promise of the Equal Rights Amendment," featuring the Rev. Dr. Serene Jones, President of Union Theological Seminary, the Rev. Dr. Traci C. West, Professor of Christian Ethics and African American Studies at Drew Theological School, and Sister Joan Chittister, OSB, Co-Chair of The Global Peace Initiative of Women.

In July we hosted "Human Rights Accountability for Systemic Racism in U.S. Policing," on the



promise of human rights to further crucial goals of safeguarding Black lives and ending racial discrimination in our criminal justice system. Panelists included Nicole Austin Hillery, Executive Director of the U.S. Program at Human Rights Watch, Prof. Justin Hansford, Executive Director of the Thurgood Marshall Center for Civil Rights at Howard University, and Prof. Gay J. McDougall, Distinguished Scholar in-Residence at Leitner Center for International Law and Justice.

The success of these offerings encouraged us to pursue a long-anticipated move of transitioning our Christian Human Rights
Education program to a new, webbased model with greater reach and impact. The result is that in 2021 we plan to offer:





- A series of dynamic, live, web-based events that bring together leading experts to address timely topics at the intersection of Christian faith and human rights—which you can participate in wherever you are.
- A companion Study,
   Discussion, & Action Guide

   event video series, to deepen

In 2020 Justice Revival stepped forward as a leading voice on equal rights and full inclusion of all people, regardless of sex, in our nation's constitution. We developed a new training program on the Equal Rights Amendment, a basic human rights reform 150 years in the making. The deep expertise we established on this historic issue also serves as the basis of an interfaith campaign Justice Revival is leading to finalize the ERA as the 28th Amendment. Look for more on the ERA in 2021, as we move ahead with faith and hope that we will see this reform solidified this year.

# Advocacy for Equality, Inclusion, & Justice

#### **Accountability for Police Killings of People of Color**

In June Justice Revival joined family members of George Floyd, Breonna Taylor, Michael Brown, and Philando Castile in calling for international scrutiny of racialized policing in the United States. In partnership with the U.S. Human Rights Network and global civil society, we urged the United Nations Human Rights Council to convene a special session to examine the pattern of police killings of people of color and the repression of resulting nationwide protests. As a result, the UN High Commissioner of Human Rights was tasked with investigating and reporting on systemic racism, policing practices, and violence against protesters in the U.S. and around the world. Justice Revival continues to follow these issues closely as we await the UN report expected in June 2021.

#### **Asylum Advocacy Days**

A Justice Revival team joined the Interfaith Immigration Coalition in a virtual advocacy campaign on behalf of families and individuals fleeing persecution and seeking asylum in the United States. Over three days of remote meetings in July, we expressed concern to Members of Congress about harmful moves by the then administration to dismantle the U.S. asylum system, including effects on vulnerable, unaccompanied children at our border. Justice Revival called on lawmakers to restore asylum protections, so the U.S. could once again serve as a beacon of hope and safety for people in need of refuge, in accord with U.S. and international law.

#### Justice Revival Leads the Way with #Faith4ERA

In January 2020 the state of Virginia became the 38th and last needed state to ratify the Equal Rights Amendment—a basic human rights reform ensuring rights cannot be "denied or abridged" based on sex. Justice Revival provided a missing and much-needed public voice of faith support to rally fellow religious leaders to the cause.

We led the development of an Interfaith Statement of Support, which over 70 Protestant, Catholic, Evangelical, Jewish, Muslim, Hindu, and Sikh faith leaders have already signed. It affirms: "all people are equally valuable in the sight of their Creator, and thus deserve equal regard in human laws and legal systems."

#### A Christian Voice for Human Rights

Justice Revival continued to speak out about the robust underpinnings of human dignity and rights found within the Christian tradition.

In October Allyson McKinney Timm preached at the **Union Theological Seminary** chapel, in a service led by former Justice Revival intern and seminarian **Kimberley Gordy**. McKinney's homily reflected on the legacy of the late Justice Ruth Bader Ginsburg, and her predecessor in human rights advocacy, the Rev. Dr. Pauli Murray.

Justice Revival was honored to present at events hosted by our friends at **Vote Common Good** in Iowa, Maryland, and online, as VCG encouraged Americans to bring "faith, hope, and love" to the fore during the challenging 2020 election season.

In a June *Sojourners* magazine article, Allyson McKinney Timm raised awareness about a periodic international review of the U.S. human rights record taking place in 2020, highlighting its value in our country's growth toward greater justice. As people across the country flooded the streets demanding police accountability and justice for Black lives, she explained, "if Americans care about human rights, we should welcome accountability and urge forthright self-evaluation," adding that this is "an opportunity all Christians of conscience can welcome."

Justice Revival continued to provide timely analysis on issues like hate crimes, gender based rights violations, systemic racism in our criminal justice system, and the importance of U.S. adherence to international law through our blog, "Faith & Human Rights Insights." # Thanks to your generosity, Justice Revival's growth accelerates

Thanks to the remarkable continued generosity of our faithful donor community, as well as the 46 new donor households who joined us this year, Justice Revival's growth accelerated significantly.

Annual contribution income was \$92,505 in 2020, representing a 55% increase over 2019.

Nearly 69% of our income came from our nationwide base of individual donors, who represent the mainstay of our financial support. Grants accounted for 14% of income and organizational donations, including matching gifts from employers and foundations, made up almost 17%.

We continued to steward these gifts carefully and experienced no increase in expenses over the prior year. This left Justice Revival with over \$40,000 in retained earnings for 2020 and a healthy \$74,652 in total assets. We are grateful to be able to make additional investments in our 2021 programs and outreach as a result.


Justice Revival was also proud to earn the **Guidestar Silver Seal of Transparency** for making important information about our mission, programs, and financial position public.






