### **Dear Fellow Justice Seekers,**

Last year, we were thrilled to reach new audiences far and wide with a message of Christian commitment to human rights. Justice Revival went back on the road and spoke to law students, seminarians, undergraduates, and fellow advocates from California to Connecticut, Georgia to West Virginia. **As always, our message focused on the moral integrity and practical power of human rights as a paradigm for the work of justice, to which the faithful are called.** 

We remained vigilant in 2022 to the threats of Christian nationalism and white supremacy, which are tragically fueling extremism and political violence in our nation. Voting rights remain a critical priority in the struggle for racial justice and a healthy, sustainable democracy—one that Justice Revival will support at every turn.

We also continued to advocate for reform to another vital component of our democratic framework: the U.S. Constitution. The Supreme Court's dramatic decision to repeal a constitutional liberty for the first time in history deepened cultural divides over reproductive justice. **Justice Revival's timely, in-depth analysis of the Dobbs v. Jackson decision shed light on a challenging issue at a critical national moment.** We were gratified to learn how many of you resonated with our commitment to both women and children, life and liberty, and how you valued hearing us voice this perspective in outlets like *Religion News Service, Christian Century*, and *Baptist News Global*.

Justice Revival's leadership circle grew stronger in 2022 with the addition of two talented new board members. Our board identified the

ongoing #Faith4ERA campaign for the Equal Rights Amendment (ERA) as a continued strategic priority, particularly since *Dobbs* has imperiled equal protection for women. **In the year to come, we will continue to grow this interfaith campaign for recognition of the ERA**, a reform that safeguards equal citizenship and brings our democracy into accord with human rights principles.

Justice Revival will also continue to deepen our flagship Christian Human Rights Education program, with seminary engagements at Yale Divinity School and The John Leland Center for Theological Studies planned for the first half of 2023. In these spaces, we'll explore the deep roots of human rights in Christian scripture, faith, and tradition to empower fellow faith leaders in their work for justice.

We hope you will continue to learn, pray, grow, and take action with us, as an act of hope in the prophetic vision of justice central to the Christian faith. We are deeply grateful for your presence, partnership, and steadfast support in this collective movement.

## **Thought Leadership** A Prophetic Voice for Human Rights

In 2022, your support equipped Justice Revival to continue speaking out as a leading Christian voice for human rights. From giving podcast interviews to penning articles in national publications, we reached audiences across the country with the message that **doing justice means upholding the inherent human rights of all**.

When the *Dobbs v. Jackson* Supreme Court decision to reverse *Roe v. Wade* was leaked in May, we were among the first to respond, offering a unique and nuanced analysis that affirmed both women's dignity and bodily integrity and the value of nascent human life. We received more positive messages in response to this commentary than ever before, and our allies at **Red Letter Christians** and **The ERA Coalition** republished the statement—highlighting the ongoing need for timely insight that reflects both faith values and legal expertise.

### **Education** Equipping People of Faith

Last year, Justice Revival reached seminarians, university students, and other audiences with our unique, faith-based human rights education. With your partnership, we also continued our "Heart of Human Rights" online event series by hosting conversations with expert speakers about the **death penalty**, **poverty**, and **violence against women**.

These collaborative online events brought together diverse speakers and audiences, including faith leaders, academics, lawyers, and grassroots activists. Audience members shared that they were inspired to put their learning into action by engaging in advocacy, initiating dialogues in their churches and communities, and joining local efforts to advance change.

## **Advocacy** Mobilizing Action for Justice & Equality

Amidst systemic injustices and rising hate crimes, Justice Revival continued to boldly defend human dignity and rights in 2022. We marched alongside the **Poor People's Campaign** in DC, encouraged support for voting rights and protections for pregnant workers, called for the abolition of the death penalty, and resisted the ongoing threats of Christian nationalism and white supremacy.

Additionally, our interfaith movement for the Equal Rights Amendment continued to gain momentum, and we were honored to welcome **NETWORK Lobby** and **The New Evangelicals** as campaign partners. Together, we raised the visibility of this essential human rights issue, advocated directly with the U.S. Archivist to publish the ERA, and continued to press Congress for support. We also rallied additional faith leader support for the ERA, with 590 signatures to date on our interfaith statement.



### **Financial Report**


Thanks to this community, Justice Revival experienced continued financial health and growth in 2022. Some 135 donor households and organizations contributed \$158,664 towards our mission—our highest level of annual giving and donor participation so far. Individual gifts accounted for 95% of this revenue and grants the remaining 5%. Justice Revival maintained an affirming donor retention rate of over 60%.

Our annual expenses totaled just over 90% of our approved budget in 2022. Over 70% of expenditures went directly toward our education and advocacy programs. We ended the year with \$30,952 in net income, \$74,634 in assets, and very grateful hearts!
